Firstly, that from 15.05.2001 to 19.03.2002 at Navsari, Surat, Valsad Districts, in pursuance of criminal conspiracy and in furtherance of your common intention, cheated the informant bank i.e. Sheth Bhagwan Das Brij Bhukhan Das Shrof Bulsar People's Bank at Valsad by dishonestly inducing it to deliver amount of Rs.28,75,31,758.33 to you, which was the property of the said bank and thereby committed an offence punishable U/sec. 420 1/w. 120-B r/w. 34 of Indian Penal Code and within my cognizance.

Secondly, on the aforesaid date, time and place you accused

in pursuance of criminal conspiracy and in furtherance of your common intention dishonestly and fraudulently caused to be transferred to your company the amount of Rs.28,75,31,758.33 intending thereby to prevent distribution of that property among the creditors of the said bank and thereby committed an offence punishable U/sec. 421 r/w. 120-B r/w. 34 of Indian Penal Code and within my cognizance.

Thirdly, on the aforesaid date, time and place you accused in pursuance of criminal conspiracy and in furtherance of your common intention prevented a debt of Rs. 28,75,31,758.33 of the Sheth Bhagwan Das Brij Bhukhan Das Shrof Bulsar People's Bank at Valsad from being made available, according to law for payment of creditors of the said bank and thereby committed an offence punishable U/sec. 422 r/w. 120-B r/w. 34 of Indian Penal Code and within my cognizance.

Fourthly, on the aforesaid date, time and place you accused in pursuance of criminal conspiracy and in furtherance of your common intention forged certain documents purported to be alriable securities i.e. fake contract notes for the Government securities, photocopies of the security bonds, blank forms, etc., intending that it shall be used for the purpose of cheating and thereby committed an offence punishable U/sec. 468 r/w. 120-B r/w. 34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
