It is the case of the complainant.

1. We are the complainant Adajana Road, Surat under the Banking Regulation Act, 1949 and Gujarat Co.Op. is a co-operative bank established and governed by the Act and bye-laws our institution has been granted necessary license by Reserve Bank of India Ahmedabad to carry out

banking operations and our bank office is located at Adajan Road, Surat. As per the resolution passed by the Board of Directors of Text Bank, we have authorized the complainant to file a legal complaint against the accused in this case and accordingly the present complaint has been filed against this case.

2. Accused No. 1 in this case is a firm named "M/s Home Trade Limited" and the firm is registered in the National Stock Exchange as a share and stock broker and accused No. 2 to 18 in this case are directors and

agents of the said firm and the accused firm is said to be engaged in issuing share securities etc. And we made such representations to the prosecutor and on such representations, the prosecutor believed them and accepted them as agents of the firm of accused No. 1 and acted. Accused Nos. 2 to 18 are managing the firm of Accused No. 1 as directors and agents, managing themselves directly supervising and responsible for

the management of the firm and in that capacity the present complaint has been filed against the accused.

3. The Plaintiff bank has paid its statutory liquidity amount which S.L.R. addressed as SLR. As per the amount to be invested in Government securities and as determined by the Reserve Bank from time to time in accordance with the provisions of this SLR Ratio Banking Regulation Act, 1949 and compliance with such orders of the Reserve Bank is mandatory for all Co-Operative Banks and it is by the way, the Plaintiff bank also S.L.R. Investment in Government securities was mandatory to maintain.
4. Accused No.3 in this case Mr. Ketan Sheth who is Mr. Neeraj Surti Chartered Accountant resident of Bharuch dated 25th September 2000 to the complainant bank which is situated near "Manthan" Muktanand Nagar, Adajan Circle and Accused No.3 stated that he is share-broker at Mumbai as well also Home Trade Limited which does government security work and its Director, as well as Accused No.4 Sanjay Agrawal who is both the Chairman and Executive of the Company. Also Accused No.2 Nandkishore Trivedi is the Executive Director of the

Company all three of them stated that they are Performer and authorized signatories of Home Trade Limited in addition, Home Trade Ltd. stated to be a Member of the National Stock Exchange and produced xerox copy of his Certificate in proof thereof, and further stated that company has a fully computerized air-conditioned office at Mumbai location with Ultra-Modern Facilities and most of the business of the Mumbai Poona Stock Exchange is being done by his firm. Claims were presented regarding the performance of the firm stating that.

Considering the above representation of accused no.3, the complainant bank entered into a contract with him to purchase a security of Rs.one crore at 12% and under this contract gave a Cheque of HDFC to the accused pursuant to which the accused delivered this security to the complainant bank.

Thereafter, the complainant bank entered into a contract dated 15/01/2001 to purchase a security of 50 lakhs bearing 10.25%, the payment of which was made by the complainant bank through a Cheque of HDFC, the delivery of which was also given to us by the accused.

On 29/08/2001 the accused firm Home Trade Limited had delivered both the previous contracts and the Reserve Bank of India had given an endorsement in favor of that bank, the complainant bank directed the accused firm to purchase a 10.25% government security of Rs.50 lakhs. The contract was awarded and the complaint bank also made the payment through the Cheque of accused HDFC.

Then on 05/12/2001 Accused No. 3 Mr. Ketan Sheth and Mr. Neeraj Surti appeared before the complainant bank and Home Trade Limited is doing Government Security work on a large scale and they are another registered company of this group Vez India Limited. A new company is also coming in the market by the name. Also his company has done commercials by Shah Rukh Khan, Hrithik Roshan, Sachin Tendulkar and Priyanka Chopra. Thus accurate claims were made about the performance of their company.

Keeping this fact in mind, they had earlier told us that the security market price of two Crores taken by them was good, so the bank would get a good profit and entered into the sale contract. Also, since the security market price of 7.5% is less than 3 Crore rupees, he was told to buy and a purchase contract was entered into and the remaining amount is from HDFC Bank adjusting the amount of the sale contract against the amount of the purchase contract. A cheque of Rs.67,26,076.38 Paisa was issued in the name of the accused firm. The accused firm had deposited it in its account and encashed it but then the complainant bank did not give it despite repeated demands from the accused for the delivery of the 7.5% security of Rs 3 crore purchased by Home Trade Limited. Thus, on 05/12/2001, the representations made by the accused were made with the intention of defrauding the bank by misappropriating the bank's money and taking delivery of all the security taken earlier by giving the contract of sale and the accused did not deliver the security as per the contract. Thus, with the intention of committing crimes, the accused has defrauded the complainant bank by taking a Cheque of a large amount and not delivering the security.

5. Believing the statement of the accused and S.L.R. for the purpose of maintenance, the plaintiff has entered into the following financial transactions with the accused in this case.

DETAILS OF FINANCIAL TRANSACTIONS

- a) Date : on 28.09.2000 the Plaintiff Bank purchased 12% SDL – 2010 security of Rs.1 Crore Home Trade Ltd., as stated and accordingly accused

gave contract note (10629). Pursuant to this purchase, the complainant bank issued a Cheque of Rs.1,00,25,000/- of HDFC. Which I have encashed Home Trade Limited. Pursuant to this payment, the above security was delivered to the bank.

- b) On 15/01/2001 the complainant bank offered to purchase CG-2012 security of 10.25% for Rs.50 lakhs and accordingly Home Trade Limited issued Contract Note No: 6401. The complainant bank issued a check to HDFC

for Rs.48,60,138.89 in lieu of this transaction which was encashed and delivered.

- c) On 29/08/2001, the complainant bank told the above accused firm to purchase 50 lakhs of GOI - 2021 Government Security bearing 10.25% and they issued Contract Note No: 6739. The complainant bank issued a Cheque of Rs.52,42,048.61 to HDFC for this transaction which was encashed by Home Trade Limited. The delivery of which was not given.
- d) On 05/12/2001 the plaintiff bank decided to sell the Government security held by them through M/s Home Trade. Accordingly the Bank has entered into an agreement to sell the following securities at the prices indicated next to it.

On the same day the complainant bank decided to purchase 7.50% CG security through M/s Home Trade which totaled Rs.000 and accordingly the accused company issued Contract Note No. 6919 which was signed by Accused No. 5 towards Accused No.1.

The plaintiff bank in pursuance of this transaction delivered the security sold by it vide contract notes Nos. 6905 and 6906 to M/s.Home Trade Limited. And the security sold vide Contract Note No.6909 was M/s.Home Trade Passage which was pending vide Security Contract Note No.6739 purchased by the Bank.

The complainant bank paid the aforesaid purchase and sale difference amount to M/s.Home Trade Limited through draft of HDFC Bank.However, the accused firm saw 7.5% purchased from M/s Home Trade Limited - 2010 purchased security valued at Rs.3,06,06,250/- against which the complainant bank has paid its full consideration.However, Home Trade Limited has failed

to provide its security. A copy of the contract referred to in this paragraph is attached herewith.

- e) In order to get the government security purchased by the complainant bank, the accused have been followed up several times by phone and in person towards the complainant, and in order to get the delivery of the government security soon, the bank has written a letter dated 25/01/2002 asking M/s Home Trade Limited to deliver the security. After that, a reminder letter was written again on 18/03/2002 and even without receiving a response, finally on 09/04/2002 the bank registered A.D. By writing a letter to the accused and asking him to deliver immediately. A copy of which is enclosed herewith.
- f) 7.5% GOI-2010 at the time of contract confirmation and payment for the purchase of securities, the accused gave full trust and confidence to the complainant bank to give physical delivery within the specified period but despite the lapse of time and despite the repeated demands of the complainant bank as shown in paragraph - (e), The bank did not, the accused maliciously and fraudulently failed

to deliver physical delivery of those securities to the complainant. So that the complainant bank said to take legal action against the accused for the same, they sent the contract dated 12/04/2002 signed on 29/03/2002 with assurance of physical delivery of 8.07% security in lieu of the security mentioned above and stated that 7.50% GOI - They executed this contract without getting it from the security market of 2010.(Certified copy is furnished herewith from the list) Further, the accused has stated that he will deliver the said Government security by 30/04/2002 and if he cannot deliver the security by 30/04/2002, then 27/05/2002 of Rs.3,24,62,700/-Cheque bearing No.984321 of HDFC Bank Nariman Point Branch said to cross the same sent (a copy of which is furnished herewith).

6. Then when the main prosecutor and director of the bank Pankaj Shah went to the office of the accused firm in Mumbai to get the security, the director of the accused firm Mr. Nandkishore Trivedi who is the Accused No.2 and if the delivery is not received,

then the accused could not give the delivery of the government security to the complainant bank even though the said check was passed but after the expiry of the period.

7. So, with the belief that the money of the Cheque given by the accused will be received after the expiry of the period, the complainant bank has drawn a Cheque dated 23/05/2002 at HDFC Bank Surat Branch and returned it to the complainant on 01/06/2002 with the share "Account blocked". When the Cheque was issued by the accused, the accused knew that the Cheque was to be returned, but with the intention to defraud the bank, the Cheque was issued by deduction. Due to the return of the cheque, a notice has been given to the accused under Section 138 of the Negotiable Instrument Act. Despite receiving the notice, the accused did not pay the due amount within the stipulated period. So we are entitled to file a separate complaint under the Negotiable Instruments Act. The complaint is for offenses under the Penal Code.
8. In the aforesaid circumstances, the accused persons in this case have fraudulently produced false and forged signatures and

coins and created trust to defraud the Plaintiff bank with the intention of embezzling the amount by stating that the Government Security can make delivery within the stipulated time and further the accused have created the trust of the Government Security. Also signed a false contract note to get the amount. But while giving such contract note, the accused were well aware that they did not have the Government Security to give to the Plaintiff and they could not give physical delivery thereof to the Plaintiff bank. However, with the intention of defrauding the bank, the Plaintiff took the money by misrepresenting the sale of the Government security and did not give physical delivery of the security and with dishonest intention and knowing that the Cheque was not going to pass, gave a stop thereafter. The Cheque is returned. In the above circumstances the accused have committed serious punishable offences, Chartered Accountant Neeraj Surti has introduced the accused Ketan Sheth to the bank and having knowledge of the transactions mentioned in the above complaint, he has tried to provide security to the bank and also helped the bank in getting suitable cheques, he is our main witness.

9. After the return of the Cheques given by the accused, during the period when the above-mentioned large amount of fraud was reported to the complainant bank, the accused persons in this case formed a criminal conspiracy from the beginning, the accused in connivance and assistance with each other have defrauded and betrayed the said complainant bank to get wrongful financial benefits and further the accused persons have It has come to the notice of the plaintiff bank that the property has been fraudulently and fraudulently acquired and

10. that the accused have done illegal acts to prevent their debt from being discharged and that the articles containing false statements about compensation are fraudulently and fraudulently acted upon. The accused in this case could not be found despite contacting their home and business addresses. Moreover, they are likely to leave India. So we have a complaint against the accused to confiscate the property they have settled and confiscate their passports and take legal action in this regard.

10. The complainant bank is a co-operative bank and the money of the complainant bank is ultimately public money and the accused in connivance with each other have fraudulently embezzled the amount mentioned in the plaint in the plaint by systematic planning and cunningly perpetrating a huge scam Section of EP Code of EP Code Section 406, 409, 420, 421, 422, 423, 465, 467, 468, 471, 114, 34, 120 (b) etc. has committed an offense punishable as follows. So we have a legitimate complaint against them.
